Cooke presented the request to change the starting wage to step 4 of the new pay scale for Highway Department positions with a CDL requirement effective January 1, 2024. Discussion followed. Motion by Spencer, 2nd by Kinsman to approve of Assistant Shop Superintendent, Crew Leader, Highway Operator II, Highway Operator III, Mechanic, Paint/Body Technician, and Welder/Fabricator starting at step 4 on the wage scale effective January 1, 2024. Motion carried unanimously.

7) Discussion and Possible Action on Sauk County Health Care Center Incentives for Current Employees. Cooke presented the proposed incentives for current Sauk County Health Care Center employees. Discussion followed. Motion by Kinsman, 2nd by Roxen to approve of the proposed incentives for Health Care Center staff effective February 4, 2024: \$2.00 per hour increase for all hourly positions plus a \$2.00 per hour increase to current hourly shift differentials; \$3,500 payment for each salaried employee through July 6, 2024, and an additional \$3,000 payment after July 6, 2024, through the last day the Sauk County Health Care Center is operated by Sauk County. Motion carried unanimously.
