ON SUNDAY, FEBRUARY 9, 2020, AT APPROXIMATELY 1:10 PM, UNIT 1, A SILVER MERCURY SABLE, BEARING WISCONSIN REGISTRATION PLATE #10217CC, BEING DRIVEN BY PRECIOUS A. WHITE-GARRETT WITH PASSENGER SETH G. REYNOLDS, WAS NORTHBOUND ON THE ON-RAMP FROM STH 136 ONTO THE NORTHBOUND LANES OF US-12. UNIT 1 ENTERED US-12. UNIT 1 CROSSED OVER THE RIGHT LANE AND OVER CORRECTED. UNIT 1 WENT INTO THE RIGHT LANE, AND OVER CORRECTED AGAIN, CROSSING THE LEFT LANE AND GOING INTO THE MEDIAN DITCH, WHERE UNIT 1 CAME TO REST. CRAIGS TOWING REMOVED UNIT 1 AND TOWED THE VEHICLE. VIA DOT RECORDS, IT WAS CONFIRMED THE DRIVER HAD A SUSPENDED WISCONSIN LICENSE AND THE PASSENGER HAD NO WISCONSIN LICENSE ISSUE WITH A STATUS BEING REVOKED. THE DRIVER ADMITTED THERE WAS NO INSURANCE ON THE VEHICLE. BOTH OCCUPANTS CLAIMED THEY WERE UNINJURED AND BOTH WERE REMOVED FROM THE SCENE BY A PASSERBY.
