ON WEDNESDAY, FEBRUARY 12, 2020, AT APPROXIMATELY 8:30 PM, UNIT 1, A RED FORD FOCUS BEARING WISCONSIN REGISTRATION PLATE #425XVH, WAS BEING OPERATED BY REGISTERED OWNER ZACHARY J. DOROW. THE FRONT PASSENGER WAS BRODIE J. MCCOY AND THE BACK PASSENGER WAS DEVON L. MCCOY. COUNTY ROAD H HAD A SPEED LIMIT OF 55 MPH. THE ROADWAY WAS SLIPPERY, SNOW COVERED, AND WAS CURRENTLY SNOWING. UNIT 1 WAS NEGOTIATING A LEFT HAND TURN WHEN UNIT 1 WENT INTO THE END OF A GUARD RAIL ON THE RIGHT HAND SIDE OF THE ROAD. UNIT 1 THEN TURNED COUNTER-CLOCKWISE FROM THE IMPACT OF THE GUARD RAIL. UNIT 1 PROCEEDED DOWN AN EMBANKMENT INTO THE DITCH ON THE RIGHT SIDE OF THE ROAD. UNIT 1 CAME TO REST AT A FENCE LINE PERPENDICULAR TO THE ROADWAY. THE FRONT AIRBAGS WERE DEPLOYED DUE TO THE INITIAL IMPACT, BUT ALL OCCUPANTS DENIED ANY INJURIES. ALL OCCUPANTS WERE ABLE TO REMOVE THEMSELVES FROM THE VEHICLE. THE VEHICLE WAS REMOVED AND TOWED BY STEVE'S AUTO. THE DRIVER WAS CITED FOR GOING TOO FAST FOR CONDITIONS. THE OCCUPANTS WERE PICKED UP BY FAMILY MEMBERS. THE SAUK COUNTY HIGHWAY SHOP WAS NOTIFIED OF THE DAMAGE TO THE GUARD RAIL AND REEDSBURG FIRE DEPARTMENT REMOVED THE DAMAGE GUARD RAIL FROM THE ROADWAY.
