ON THE DESCRIBED DATE, TIME, AND LOCATION, UNITS 1 AND 2 WERE STOPPED AT A STOP SIGN WITH UNIT 1 BEHIND UNIT 2. AT ONE POINT, THE OPERATOR OF UNIT 2 PULLED SLIGHTLY FORWARD TO LOOK AROUND A SEMI SO SHE COULD MAKE A RIGHT TURN. THE OPERATOR OF UNIT 1 ASSUMED UNIT 2 WAS LEAVING THE INTERSECTION, BUT THE OPERATOR OF UNIT 2 STOPPED. WHILE THE OPERATOR OF UNIT 2 WAS STOPPING, THE OPERATOR OF UNIT 1 LOOKED LEFT TO CHECK FOR TRAFFIC AND BUMPED INTO UNIT 2. NO REPORTED INJURIES.
