 UNIT WAS SB ON CTH A. UNIT ENTERED A CONSTRUCTION ARE ON CTH A JUST SOUTH OF CTH T/ BUNKER RD AND STRUCK A TRAFFIC BARRIER IN THE SOUTHBOUND LANE, PUSHING IT INTO THE YARD AT S2115 CTH A. THE HOMEOWNER REPORTED HEARING IT AT 1440 , BUT DID NOT SEE THE VEHICLE INVOLVED. A DARK COLORED SUV PULLED UP A FEW MINUTES LATER AND SOMEONE GOT OUT AND PICKED SOMETHING UP IN THE AREA. HOMEOWNER REPORTED POSSIBLY A DARK COLORED SUV. HE HAD NO FURTHER INFORMATION. I FOUND A PIECE OF A SIDE MIRROR AND LOCATED INFORMATION ONLINE THAT IT LIKELY HAD CAME OFF A 2002-2005 FORD EXPLORER. THE BARRIER HAD A DAMAGED FOOTING AND A NEW ONE WAS SET BY THE SAUK COUNTY HIGHWAY SHOP PERSONEL. THE UNIT INVOLVED HAS NOT BEEN IDENTIFIED.
