ON SATURDAY, 6/26/2021, AT APPROXIMATELY 10:05 PM, UNIT 1, A SILVER CHEVROLET CAVALIER, BEARING WISCONSIN REGISTRATION PLATE # ALT2631, WAS DRIVEN BY SEAN D. ABBOTT. THE ROADWAY OF CTH A WAS WET FROM RECENT RAIN AND THE SPEED LIMIT OF ROADWAY WAS POSTED AT 55 MPH. UNIT 1 WAS NORTHBOUND AND THE DRIVER CLAIMED A VEHICLE PASSED HIM AND WAS AT A VERY CLOSE DISTANCE OF WHICH THE DRIVER THOUGHT THE VEHICLE WOULD BE SIDE-STRUCK. THE DRIVER THEN QUICKLY SHIFTED THE WHEEL TO THE RIGHT AND ATTEMPTED TO RECOVER TO THE LEFT. UNIT 1 THEN CROSSED THE CENTER LINE, WENT INTO THE SOUTHBOUND DITCH, ACROSS THE DRIVEWAY OF S2777 CTH A AND CAME TO REST IN THE DITCH LINE. THE VEHICLE IN THE DITCH WAS CALLED IN BY A PASSERBY WHO DID NOT WITNESS THE INCIDENT. UNIT 1 WAS REMOVED BY THE OPERATOR FROM THE DITCH. UPON ARRIVAL OF LAW ENFORCEMENT, THE DRIVER WAS CHECKING TO SEE IF THE DAMAGE OF DISABLING OR NOT. FRIENDS ARRIVED ON SCENE OF THE DRIVER, IDENTIFIED AS RICHARD MECKLENBURG AND AMANDA PIERCE, IF A RESCUE PARTY WAS NEEDED. THE DRIVER WAS UNINJURED, THE VEHICLE WAS DRIVEABLE, AND WAS REMOVED BY THE OPERATOR.
