THE OPERATOR WAS HARD TO EVEN UNDERSTAND DUE TO SLURRED SPEECH. OPERATOR WAS NOT ABLE TO GIVE ME ANY INSURANCE INFORMATION. OPERATOR ALSO STATED HE HAD HIS CELL PHONE ON HIM HOWEVER HAD NO REASON WHY HE WAITED UNTIL HE GOT HOME TO CALL 45 MINUTES LATER. VEHICLE WAS REMOVED BY CRAIG'S TOWING. OPERATOR MAILED TWO CITATIONS.

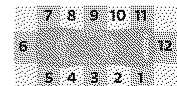
