UNIT 1 OPERATOR WAS ON DUTY FIRE DEPARTMENT. AT SCENE OF A CRASH ON HWY 60 AND RAINBOW RD. UNIT 1 OPERATOR STATED HE WAS DIRECTED TO MOVE HIS LOCATION FROM THE CRASH SCENE TO HWY 60 AND DAVIES RD TO DIVERT TRAFFIC. UNIT 1 OPERATOR STATED HE WAS WESTBOUND ON HWY 60 WITH HIS EMERGENCY LIGHTS ACTIVATED. UNIT 1 OPERATOR STATED HE PULLED INTO THE EASTBOUND LANE TO STOP TRAFFIC, THIS WAS APPROX .36 MILES WEST FROM CRASH SCENE. UNIT 1 OPERATOR STATED AFTER STOPPING TRAFFIC AT THIS LOCATION HE WAS THEN GOING TO TURN AROUND. UNIT 1 OPERATOR STATED HE BEGAN TO TURN BACK INTO THE WESTBOUND LANE. UNIT 1 OPERATOR STATED HE CHECKED HIS MIRRORS BEFORE TURNING AND DID NOT SEE ANY VEHICLES. AS UNIT 1 BEGAN HIS TURN BACK INTO THE WESTBOUND LANE HE STRUCK UNIT 2, WHICH WAS WESTBOUND ON HWY 60. MINOR DAMAGE TO THE PASSENGER SIDE FRONT BUMPER TO UNIT 1. I MADE CONTACT WITH UNIT 2 OPERATOR WHO STATED SHE APPROACHED THE CRASH SCENE (HEADING EASTBOUND) AND TURNED AROUND, DUE TO NOT BEING ABLE TO GET THROUGH THE SCENE. UNIT 2 OPERATOR STATED SHE WAS WESTBOUND ON HWY 60 AS SHE BEGAN TO APPROACH UNIT 1, WHICH HAD EMERGENCY LIGHTS ACTIVATED. UNIT 2 OPERATOR STATED UNIT 1 WAS IN THE EASTBOUND LANE STOPPING TRAFFIC, FACING WEST. UNIT 2 OPERATOR STATED SHE BELIEVED UNIT 1 WAS STOPPED. UNIT 2 OPERATOR STATED SHE BEGAN TO SLOWLY PASS BY UNIT 1 IN HER LANE OF TRAVEL, WESTBOUND. UNIT 2 OPERATOR STATED AS SHE CONTINUED BY UNIT 1, UNIT 1 BEGAN MAKING A TURN INTO THE WESTBOUND LANE. UNIT 2 OPERATOR STATED SHE TRIED TO AVOID UNIT 1 BUT IT
