UNIT 1 OPERATOR WAS TRAVELING W/B ON E REDSTONE DR, WHEN THE OPERATOR ATTEMPTED TO MADE A LEFT TURN ONTO SAC CT. UNIT 1 OPERATOR CUT THE CORNER AT THE INTERSECTION OF E REDSTONE DR AND SAC CT LEAVING THE ROADWAY AND ENTERED THE DITCH. UNIT 1 CONTINUED TO TRAVEL OVER SAC CT INTO THE FRONT YARD OF S1481 SAC CT. UNIT 1 CONTINUED THROUGH THE FRONT YARD AND STRUCK THE CORNER OF HOUSE/GARAGE CAUSING SIGNIFICANT DAMAGE TO THE HOUSE/GARAGE. UNIT 1 CONTINUED THROUGH THE HOUSE/GARAGE AND DOWN AN EMBANKMENT. UNIT 1 CONTINUED DOWN THE EMBANKMENT, POSSIBLY ROLLED, STRUCK MULTIPLE TREES AND CAME TO REST ON ITS DRIVERS SIDE. UNIT 1 HAD DISABLING DAMAGE. LA VALLE FIRE DEPARTMENT RESPONDED TO THE SCENE TO STABILIZE UNIT 1 SO THE OPERATOR COULD BE REMOVED. SHIELDS TOWING REMOVE UNIT 1.
