UNIT 1 WAS ON THE SIDE OF THE STREET, IN THE PARKING ZONE OF THE STREET, DELIVERING MAIL. UNIT 1 PULLED AHEAD FROM THE MAILBOXES, LOCATED AT 216 LOCUST STREET, VILLAGE OF WEST BARABOO, SAUK COUNTY, WISCONSIN. UNIT 1 CAME TO A STOP WITHIN ITS LANE, WHEN THE DRIVER LOOK AT THE MAIL FOR NEXT DELIVERY. UNIT 1 STARTED TO PROCEED FORWARD. UNIT 2, A 2014 BLUE SILVERADO BEARING WISCONSIN REGISTRATION PLATE # NW9789, WAS DRIVEN BY TERRANCE J. BRISTOL. UNIT 2 PASSED UNIT 1, ACTIVATED ITS RIGHT TURN SIGNAL AND TURNED IN FRONT OF UNIT 1 TO PARK. UNIT 1 STRUCK UNIT 2 IN THE PASSENGER REAR CORNER PANEL WITH A MIRROR, CAUSING A SCRATCH IN THE PAINT. UNIT 2'S REAR PASSENGER SIDE WHEEL WENT OVER THE FRONT DRIVER'S SIDE CORNER OF THE UNIT 1'S BUMPER, CAUSING NO DAMAGE. NO INJURIES WERE SUSTAINED BY EITHER DRIVER. BOTH VEHICLES WERE REMOVED BY EACH OPERATOR.

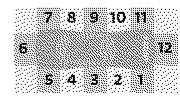
