OPERATOR HAD MINOR INJURIES AND REFUSED EMS CARE. OPERATOR HAD BEEN TRAVELING NORTH ON COON BLUFF RD AND ENTERED THE EAST SIDE DITCH STRIKING THE DITCH AND LARGE ROCKS. VEHICLE ROLLED OVER AND OPERATOR CONTINUED GOING NORTH BEFORE THE VEHICLE BECAME DISABLED. OPERATOR WAS ARRESTED FOR OWI 1ST. VEHICLE REMOVED BY CRAIGS TOWING. IT SHOULD BE NOTED ANOTHER SAUK COUNTY SQUAD CAR RESPONDING TO THE CRASH HAD STRUCK DEBRIS FROM THE CRASH SCENE, WHICH WAS APPROXIMATELY A HALF MILE SOUTH OF WHERE THE VEHICLE WAS LOCATED. 
