ON 6/10/2022, AT APPROXIMATELY 4:08 PM, UNIT 1 STOPPED AT THE STOP SIGN ON GOLF COURSE ROAD AT STH 154. UNIT 1 PROCEEDED INTO THE INTERSECTION AFTER NOT SEEING UNIT 2 DRIVING WESTBOUND ON STH 154. UNIT 1 STRUCK THE FRONT DRIVER SIDE AREA OF UNIT 2, CAUSING BOTH OF THEM TO ENTER THE DITCH. UNIT 1 STRUCK A STOP SIGN ON THE OPPOSITE SIDE OF THE INTERSECTION. UNIT 1 CAME TO A REST IN THE DITCH. UNIT 2 CAME TO REST IN THE DITCH. STEVES TOWING REMOVED BOTH VEHICLES FROM THE SCENE. THE DRIVER OF UNIT 1 WAS TRANSPORTED BY AMBULANCE TO REEDSBURG AREA HOSPITAL. THE DRIVER OF UNIT 2 WAS PICKED UP BY A RESCUE PARTY.
