OPERATOR OF U1 INFORMED CHRISTMAS MOUNTAIN STAFF HE SIDE SWIPED A TREE AND WOULD REMOVE THE VEHICLE THE FOLLOWING DAY, I WAS THEN NOTIFIED BY CHRISTMAS MOUNTAIN STAFF. I CONTACTED THE OPERATOR WHICH HE SAID HE WAS UNSURE WHERE HE WAS WHEN THE CRASH HAD OCCURRED. THE OPERATOR ADMITTED TO SIDE SWIPING A TREE DUE TO MANIPULATING HIS CELL PHONE. THE OPERATOR ALSO ADMITTED TO NOT NOTIFYING LAW ENFORCEMENT OF THE CRASH. THE OPERATOR STATED HE WAS UNINJURED AND WOULD CONTACT A TOW COMPANY TO REMOVE THE VEHICLE. ON A LATER DATE, I CONTACTED THE OPERATOR ONCE AGAIN AND ASKED MORE QUESTIONS. THE OPERATOR ADMITTED ONCE AGAIN TO MANIPULATING HIS PHONE AND GOING OFF THE ROAD AND SIDE SWIPING A TREE WITH HIS VEHICLE. THE OPERATOR ALSO STATED HE WAS NEAR DEVIL'S LAKE STATE PARK WHEN THE CRASH OCCURRED, BUT WAS UNABLE TO DESCRIBE FURTHER WHERE THE INCIDENT TOOK PLACE. I PLACED THE LOCATION OF THE CRASH AT THE LOCATION OF THE FOUND VEHICLE DUE TO NOT KNOWING THE TRUE CRASH LOCATION. THE OPERATOR RECEIVED A CITATION FOR THE INATTENTIVE DRIVING AND FAILURE TO NOTIFY LAW ENFORCEMENT.
