UNIT 1 WAS TRAVELING NORTHBOUND ON STH 113 AND APPROACHED A RIGHT HANDED CURVE. UNIT 1 THEN ENTERED THE CURVE AND BEGAN TO SLIDE IN A CLOCKWISE ROTATION, DUE THE RAINY AND WET ROAD CONDITIONS. UNIT 1 THEN ENTERED THE EAST DITCH, TRAVELED UP AN EMBANKMENT AND BEGAN TURNING BACK COUNTER CLOCKWISE. AS UNIT 1 WAS DESCENDING THE EMBANKMENT, IT OVERTURNED DRIVER SIDE OVER PASSENGER SIDE. UNIT 1 CAME TO REST ON ITS ROOF FACING WEST. THERE WERE NO REPORTED INJURIES FROM ANY OF THE OCCUPANTS. THE OPERATOR AND PASSENGER 3 (P3) WERE BOTH WEARING SEATBELTS AT THE TIME OF THE CRASH. P2 SAID THEY WERE NOT WEARING THEIR SEATBELT AT THE TIME OF THE CRASH. THE OPERATOR, OPERATING UNDER GDL RESTRICTIONS OF ONLY 1 PASSENGER, WAS CITED FOR VIOLATING GDL RESTRICTIONS AND DRIVING TOO FAST FOR CONDITIONS. P2 WAS CITED FOR NOT WEARING A SEATBELT. ALL THE PARENTS OF THE OCCUPANTS WERE CONTACTED AND ADVISED. THE VEHICLE WAS REMOVED FROM THE SCENE BY CRAIG'S TOWING.
