ON 12/15/2022, I WAS DISPATCHED TO A TRAFFIC ACCIDENT ON KENNEDY ROAD AND BLAU ROAD IN THE TOWN OF SPRING GREEN. UPON ARRIVAL, I OBSERVED UNIT 1 IN THE DITCH ON THE RIGHT SIDE OF THE ROAD. UNIT 1 OPERATOR STATED HE WAS TRAVELING WESTBOUND ON KENNEDY ROAD WHEN HE SLID OFF THE ROADWAY WHILE NEGOTIATING A SHARP LEFT TURN. UNIT 1 OPERATOR STATED THE ROADWAY WAS ICY, WHICH CAUSED HIM TO RUN OFF THE ROADWAY. I OBSERVED KENNEDY ROAD AND BLAU ROAD TO BE ICY. UNIT 1 OPERATOR STATED HE HIT A CHEVRON SIGN KNOCKING IT OVER. UNIT 1 STATED HE CONTINUED IN THE DITCH UNTIL UNIT 1 STRUCK A LARGE ROCK, STOPPING UNIT 1. UNIT 1 SUSTAINED DISABLING DAMAGES. WEGNER'S TOWING REMOVED THE UNIT 1 FROM THE DITCH. UNIT 1 OPERATOR WAS ABLE TO DRIVE UNIT 1 TO A PARKING LOT. UNIT 1 OPERATOR HAD ARRANGEMENTS WITH WEGNER'S TOWING TO GET THE UNIT 1 TOWED.
