

UNIT 1 MADE A QUICK LANE CHANGE TO THE OUTSIDE LANE TO AVOID A VEHICLE THAT WAS STOPPED. THE OPERATOR OF UNIT 1 ADVISED SHE SWERVED BECAUSE SHE COULDN'T SLOW DOWN IN TIME DUE TO SNOW ON THE ROADWAY. UNIT 2 COLLIDED WITH THE REAR END OF UNIT 1.

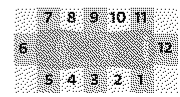
