UNIT 1 WAS TRAVELING WESTBOUND ON STH 23 AND VEERED OFF THE ROADWAY TO THE NORTH SHOULDER. UNIT 1 THEN STRUCK THE MAILBOX BELONGING TO THE ADDRESS OF E9048 STH 23. UNIT 1 THEN STEERED SOUTH, CROSSED OVER THE EASTBOUND LANE, AND ENTERED THE SOUTH DITCH WHERE IT CAME TO REST, FACING WEST. THE OPERATOR REPORTED NO INJURIES AND WAS WEARING A SEAT BELT. THE VEHICLE SUSTAINED DISABLING DAMAGE WITH AIRBAG DEPLOYMENT. THE VEHICLE WAS TOWED FROM THE SCENE BY BILL'S TOWING. A DOT CHECK OF THE VEHICLE FOUND THAT THE REGISTRATION HAD EXPIRED ON 07/07/23. THE OPERATOR WAS IDENTIFIED BY HIS NICARAGUAN PASSPORT AND SHOWED NO VALID DRIVERS LICENSE. THE OPERATOR ALSO TOLD ME HE HAD NO DRIVERS' LICENSE. THE OPERATOR SAID HE WAS TIRED AND LOST CONTROL OF THE STEERING WHEEL. THE OPERATOR WAS ISSUED AND EXPLAINED CITATIONS FOR DEVIATING FROM DESIGNATED LANE, OPERATING WITHOUT A VALID DRIVERS LICENSE, NON REGISTRATION OF AUTO, AND NO INSURANCE.

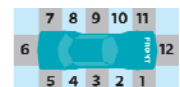
