UNIT 1 WAS TRAVELING SOUTH AT A SPEED THE OPERATOR STATED WAS 70 MPH WHEN THE OPERATOR WITNESSED A DEER ON THE EAST SIDE DITCH LINE. THE OPERATOR ATTEMPTED TO CHANGE LANES, LOOSING CONTROL OF THE VEHICLE. THE VEHICLE THEN ENTERED THE EAST DITCHLINE AND ROLLED MULTIPLE TIMES, ENDING OFF THE ROADWAY. THE OPERATOR OF UNIT 1 WAS ABLE TO FREE HIMSELF FROM THE VEHICLE AND WALKED TO A RESIDENCE FURTHER NORTH AND LAW ENFORCEMENT WAS CONTACTED. OPERATOR OF UNIT 1 ADMITTED TO CONSUMING ALCOHOL AFTER THE CRASH, BUT DENIED CONSUMING ALCOHOL BEFORE CRASH.
