

UNIT 1 WAS TRAVELING EB ON CTH H BETWEEN BLUEBIRD LN AND TOWNHALL RD. UNIT 1 OPERATOR, ANTHONY STOCKDILL, REPORTED DRIFTING OFF ROADWAY INTO THE EB DITCH AND STRIKING A GUARDRAIL END. ANTHONY THEN DROVE HIS VEHICLE TO THE OPPOSITE SIDE SHOULDER WHERE THE VEHICLE REMAINED PARKED UPON MY ARRIVAL. ANTHONY EXPLAINED HE WAS COMING FROM WORK IN REEDSBURG AS A FORKLIFT DRIVER AND WAS GOING HOME. ANTHONY WAS CHECKED OVER BY EMS AND LATER DENIED INJURIES AND TRANSPORT TO HOSPITAL. ANTHONY DENIED ALCOHOL USAGE BUT STATED HE IS A DAILY MJ SMOKER AND LAST SMOKED APPROX 4 HOURS PRIOR TO DRIVING. NO OTHER OCCUPANTS WERE OBSERVED IN THE VEHICLE AND ANTHONY STATED HE LEFT WORK AT APPROXIMATELY 4:15 AM, AND WAS UNSURE EXACTLY WHEN CRASH HAPPENED. SFST CONDUCTED AND ANTHONY WAS LATER 10-95 FOR OWI 4. PLATTS TOWING REMOVED THE SUSPECT VEHICLE.
