ON 11/26/2023, I WAS DISPATCHED TO THE AREA OF E6672 SKI HILL ROAD IN THE TOWN OF REEDSBURG FOR A TRAFFIC ACCIDENT. UPON MY ARRIVAL, I OBSERVED A VEHICLE ON THE LEFT SIDE OF THE ROAD AGAINST A TREE. I ALSO OBSERVED THE ROADWAY TO BE COVERED IN SNOW AND ICE. I MADE CONTACT WITH UNIT 1 OPERATOR, WHO STATED HE WAS TRAVELING E/B ON SKI HILL ROAD WHEN A DEER RAN OUT IN FRONT OF HIM. UNIT 1 OPERATOR STATED HE TRIED TO SWERVE AND MISSED THE DEER AND ENDED UP HITTING A TREE, CAUSING DISABLING DAMAGE TO UNIT 1. UNIT 1 OPERATOR STATED HE WAS GOING BETWEEN 50 MPH AND 55 MPH WHEN THE ACCIDENT OCCURRED. SKI HILL ROAD IS A 45 MPH ZONE ROAD. UNIT 1 OPERATOR WAS TRANSPORTED TO A HOSPITAL BY HIS PARENT. UNIT 1 WAS REMOVED MY CRIAGS TOWING. UNIT 1 OPERATOR WAS CITED FOR TOO FAST FOR CONDITIONS.

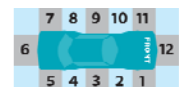
