ON 04/14/2024, I WAS DISPATCHED TO USH 12 AND SKI HI ROAD IN THE TOWN OF SUMPTER FOR A TWO-VEHICLE TRAFFIC CRASH. UNIT 1 OPERATOR STATED SHE WAS AT A STOP SIGN ON SKI HI ROAD AND WAS TRYING TO TURN LEFT ONTO THE E/B LANE OF USH 12. UNIT 1 OPERATOR STATED SHE LOOKED BOTH WAYS BUT DID NOT SEE UNIT 2 BECAUSE OTHER VEHICLES WERE IN THE TURN LANE. UNIT 1 OPERATOR THOUGHT THE E/B LANES WERE CLEAR OF TRAFFIC. UNIT 1 OPERATOR WENT ACROSS THE E/B LANE SO SHE COULD TURN LEFT ONTO THE W/B LANE OF USH 12. UNIT 1 OPERATOR HIT UNIT 2 IN THE REAR PASSENGER SIDE OF THE VEHICLE. UNIT 2 OPERATOR STATED HE WAS TRAVELING E/B ON USH 12 WHEN UNIT 1 PULLED INTO THE TRAVEL LANE FROM SKI HI ROAD. UNIT 2 OPERATOR STATED UNIT 1 HIT UNIT 2 IN THE REAR PASSENGER SIDE OF UNIT 2. UNIT 2 OPERATOR STATED HIS BACK WAS HURTING BUT DID NOT NEED EMS. UNIT 2 WAS REMOVED BY CRAIGS' TOWING.

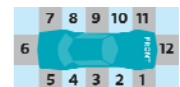
