

ON 07/06/2025 I WAS REQUESTED TO RESPOND TO A ONE VEHICLE ACCIDENT ON CTH DL. I ARRIVED ON SCENE AND OBSERVED THE VEHICLE HAD BEEN TRAVELING WEST ON CTH DL. THE VEHICLE MADE AN EVASIVE MANEUVER AND TRAVELED INTO THE EAST BOUND LANE OF CTH DL BEFORE OVER CORRECTING AND ENTERING THE NORTH DITCH. THE VEHICLE STRUCK A ROAD SIGN ON THE NORTH SHOULDER. THE VEHICLE WAS UNOCCUPIED AND LOCKED UP IN THE DITCH. THERE WAS MINIMAL DAMAGE TO THE TRUCK. THE OWNER CALLED IN THE FOLLOWING DAY REPORTING THE CRASH AND THAT HE WAS THE DRIVER. OWNER STATED HE SWERVED TO MISS A DEER. OWNER STATED IT WAS A BAD CHOICE NOT TO CALL WHEN IT HAPPENED. OWNER STATED HE WASN'T WEARING A SEATBELT IN THE CRASH. CITATIONS WERE EXPLAINED OVER THE PHONE AND THEN MAILED TO THE OPERATOR.
