ON 09/18/2025, I RESPONDED TO THE AREA OF E6473 IRISH VALLEY ROAD IN THE TOWN OF FRANKLIN FOR A TRAFFIC CRASH. UNIT 1 WAS TRAVELING W/B ON IRISH VALLEY ROAD. UNIT 1 OPERATOR DID NOT KNOW HOW HE CRASHED. UNIT WAS TRYING TO NEGOTIATE A SLIGHT RIGHT-HAND CURVE AND ENTERED THE DITCH RESULTING IN UNIT 1 ROLLING OVER MULTIPLE TIMES INTO A CORNFIELD. UNIT 1 OPERATOR GOT OUT OF VEHICLE AND WALKED THROUGH THE CORNFIELD AND MADE HIS WAY TO THE SIDE OF THE ROADWAY AROUND 300 YARDS AWAY FROM UNIT 1. UNIT 1 OPERATOR WAS CHECKED OUT BY PLAIN EMS AND BECAME AGGRESSIVE TOWARDS THEM AND DENIED MEDICAL TREATMENT. UNIT 1 OPERATOR WAS TRANSPORTED TO SPH FOR FURTHER MEDICAL NEEDS, AN OWI INVESTIGATION, AND CHAPTER 51.15 EVALUATION DUE TO UNIT 1 OPERATOR MAKING SUICIDAL STATEMENTS. UNIT 1 OPERATOR WAS CITED FOR OPERATING WHILE INTOXICATED AND TOO FAST FOR CONDITIONS. NACHREINERS TOWING REMOVED THE VEHICLE.
