OPERATOR OF U1 STATED SHE WAS EASTBOUND ON HY33 WHEN SHE SAW A VEHICLE THAT WAS IN FRONT OF HER, U2, WAS WAITING TO TURN LEFT INTO A DRIVEWAY. PROPERTY LOCATION OF THE CRASH DID NOT RECEIVE ANY DAMAGE. CRAIG'S TOWING RESPONDED FOR THE VEHICLE.
