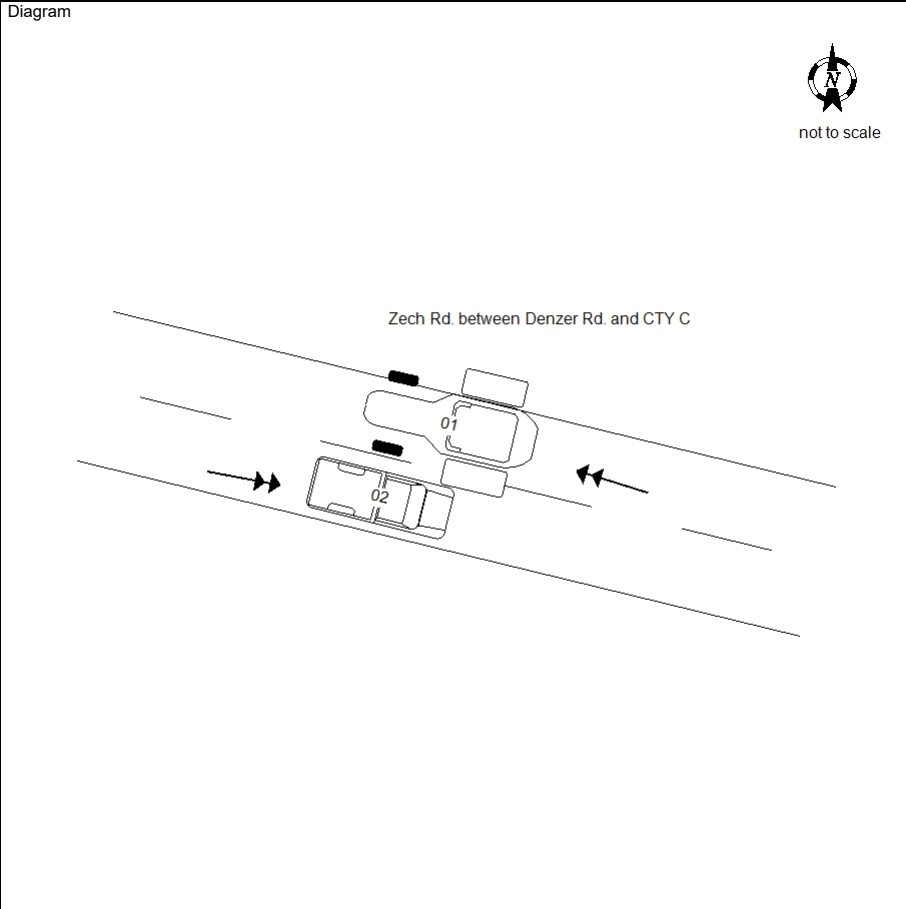

UNIT 1 WAS W/B ON ZECH RD APPROACHING DENZER RD. UNIT 2 TURNED OFF DENZER RD. ONTO ZECH RD. OPERATOR OF UNIT 2 STATED BOTH VEHICLES ATTEMPTED TO GET OVER AS FAR AS THEY COULD TO EITHER SIDE BUT DUE TO THE ROAD BEING NARROW, THE TRACTOR TIRE STRUCK HIS SIDE MIRROR, CAUSING DAMAGE. OPERATOR OF UNIT 1 STATED HE WAS NEARLY AT THE INTERSECTION IN THE TRACTOR, AND HE WAS WELL OVER AND THERE WAS PLENTY OF ROOM FOR THE TRUCK TO GET BY. OPERATOR OF UNIT 1 STATED THE OPERATOR OF UNIT 2 SAID TO HIM "SORRY I WAS OVER THAT FAR, I DIDN'T REALIZE IT." BOTH UNITS LEFT THE SCENE BEFORE OPERATOR OF UNIT 2 REPORTED THE ACCIDENT.

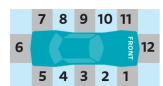

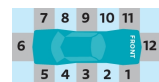
