UNIT 1 WAS STATIONARY IN A PRIVATE DRIVEWAY WAITING TO TURN RIGHT/NORTH BOUND ON STH 23. UNIT 2 WAS TRAVELING SOUTH BOUND ON STH 23 AND WAITING TO PASS ANOTHER UNIT HAULING A TRAILER. UNIT 2 DRIVER STATED HE ENTERED THE NORTH BOUND LANE OF TRAVEL TO PASS THE SLOW MOVING UNIT HAULING A TRAILER, AT THE BEGINNING OF THE STRIPED PASSING ZONE. UNIT 1 DRIVER STATED SHE LOOKED AND DIDN'T SEE ANY ON COMING TRAFFIC IN HER LANE OF TRAVEL. UNIT 1 TURNED RIGHT ONTO STH 23 IN CLOSE PROXIMITY OF TIME TO WHEN UNIT 2 WAS MAKING A PASS. UNITS 1 AND 2 CRASHED IN A HEAD ON STYLE CRASH IN THE NORTH BOUND LANE OF TRAVEL. THE START OF THE PASSING ZONE IN RELATION TO THE APPROXIMATE START OF THE PRIVATE DRIVEWAY WAS APPROXIMATELY 65 YARDS.
