



ON 12/25/2025, AT APPROXIMATELY 4:56 AM, UNIT 1, A 2014 CHEVROLET CRUZE BEARING WI# AXU5499, WAS SOUTHBOUND/EASTBOUND ON US 12 AT 218 MILE MARKER, TOWNSHIP OF BARABOO, SAUK COUNTY, WISCONSIN, THE DRIVER OF UNIT 1 FAILED TO MAINTAIN CONTROL AND STRUCK THE END OF THE GUARDRAIL AND CONTINUE WITH STRIKING THE FACE OF THE GUARDRAIL LOCATED ON THE MEDIAN SIDE OF THE SOUTHBOUND/EASTBOUND LANES. UNIT 1 SUSTAIN DISABLING DAMAGE. UNIT 1 CONTINUED ON TO THE NEAREST OFF RAMP AND THE DRIVER REPORTED THE ACCIDENT. THE DRIVER ADVISED HE WAS "FALLING ASLEEP," WHEN THE ACCIDENT OCCURRED. PLATZ TOWING REMOVED THE VEHICLE AND A RESCUE PARTY REMOVED THE UNINJURED DRIVER.
