UNIT ONE WAS TRAVELING WESTBOUND ON HY 23-33, APPROACHING THE TRAFFIC CIRCLE AT HY 136. UNIT ONE CROSSED THE CENTERLINE AND LEFT THE ROADWAY ON THE SOUTH SIDE OF THE ROADWAY. UNIT ONE DROVE IN THE DITCH, HIT AN EMBANKMENT FOR A DRIVEWAY, WENT AIRBORNE, AND CAME DOWN ON THE OTHER SIDE OF THE DRIVEWAY, CAUSING DISABLING DAMAGE TO THE VEHICLE. UNIT ONE CAME TO A STOP IN THE DITCH. OPERATOR ATTEMPTED TO REMOVE THE VEHICLE BUT WAS UNABLE TO DUE TO THE SNOW. OPERATOR DID NOT KNOW WHAT HAPPENED, BELIEVED HE WAS TRAVELING FROM TWO CITIES IN ILLINOIS, AND APPEARED TO BE DISORIENTED. EMS TRANSPORTED DUE TO SUSPECTED MEDICAL ISSUE/CONDITION.
