UNIT 1 WAS TRAVELING EASTBOUND ON CTH U JUST EAST OF CTH A IN BARABOO, WI. UNIT 1 STATED HIS FLOOR MAT CAUSED THE THROTTLE TO GET STUCK AND WAS UNABLE TO MANIPULATE THE BRAKE OR THE THROTTLE. UNIT 1 OPERATOR STATED HE OBSERVED THERE WAS A VEHICLE AHEAD OF HIM SO HE SWERVED LEFT TO MISS THE VEHICLE. UNIT 1 THEN SLID ON A PORTION OF THE ROADWAY THAT WAS ICE COVERED WHICH CAUSED HIM TO FISHTAIL INTO THE DITCH. NO INJURIES REPORTED. UNIT 1 REMOVED BY BLYSTONES TOWING. I DID VERIFY AND PHOTOGRAPH THE FLOOR MAT THAT WAS STUCK IN BETWEEN THE CONTROLS.
