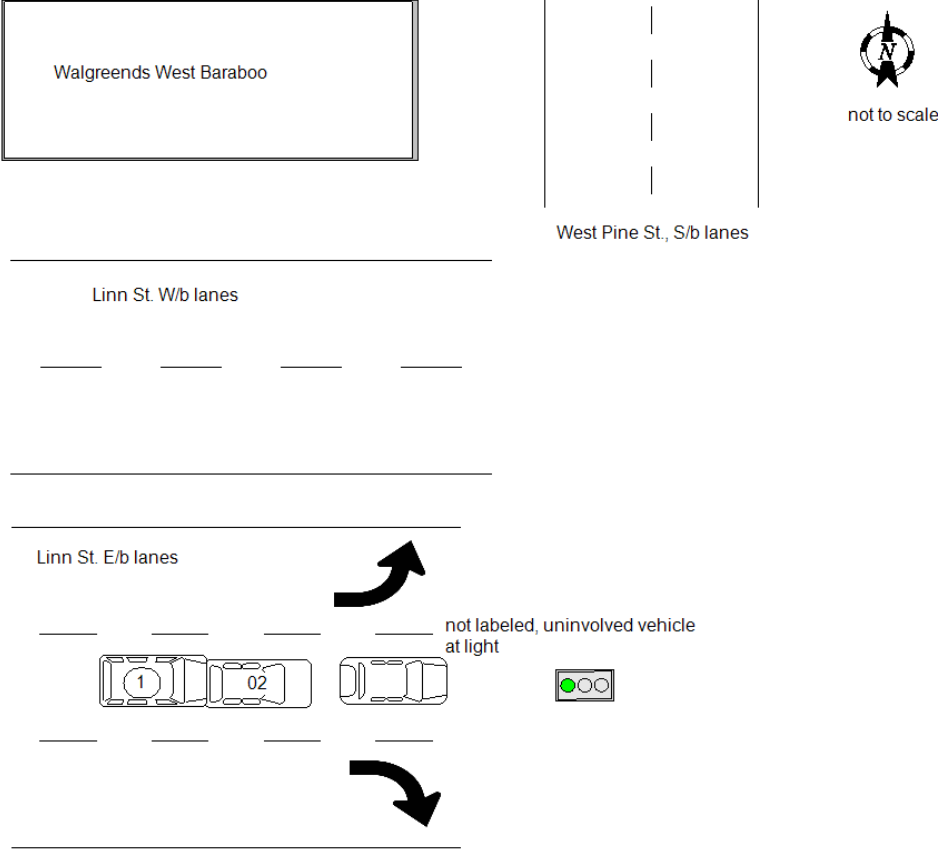

UNIT 2 WAS STOPPED AT THE RED LIGHT TRAVELING E/B ON LINN ST., AT WEST PINE ST. THERE WAS AT LEAST ONE VEHICLE IN FRONT OF UNIT 2. UNIT 1 WAS STOPPED DIRECTLY BEHIND UNIT 2. OPERATOR OF UNIT 1 WAS DIGGING THROUGH A BAG ON THE PASSENGER FLOORBOARDS AND NOTICED THE LIGHT TURN GREEN. OPERATOR OF UNIT 1 LOOKED UP, CONFIRMED THE LIGHT WAS GREEN, AND ACCELERATED WHILE LOOKING BACK INTO THE BAG TO KEEP LOOKING FOR AN ITEM. UNIT 2 WAS NOT ABLE TO ACCELERATE BECAUSE THE VEHICLE IN FRONT OF IT WAS SLOW TO ACCELERATE AT THE GREEN LIGHT. THE FRONT OF UNIT 1 STRUCK THE REAR OF UNIT 2. BOTH UNITS PULLED INTO A NEARBY PARKING LOT AND WAITED FOR LAW ENFORCEMENT.

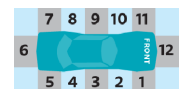

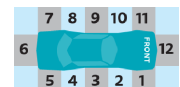
