UNIT WAS WAS WB ON DORE RD COMING INTO A RIGHT HAND CURVE, TRAVELING ON SNOWCOVERED ROADWAY DURING A HEAVY ACTIVE SNOWSTORM. UNIT BEGAN TO SLIDE TOWARDS THE LEFT SIDE.
