ON THE DESCRIBED DATE, TIME, AND LOCATION, UNIT 1 WAS TRAVELING NORTHBOUND. WHILE NORTHBOUND, THE OPERATOR STRUCK SOME GRAVEL ON THE SIDE OF THE ROADWAY WHILE HE WAS ATTEMPTING TO NEGOTIATE A CURVE. THIS CAUSED HIM TO LOSE CONTROL OF UNIT 1. UNIT 1 ENTERED THE NORTHERNMOST DITCH LINE WHERE IT EVENTUALLY LAID ON ITS SIDE. OPERATOR HAD ROAD RASH BUT REFUSED TRANSPORT TO THE LOCAL HOSPITAL.
