THE OPERATOR OVER CORRECTED AND RE ENTERED THE LANE OF TRAFFIC. THE OPERATOR AGAIN CORRECTED AND ENTERED THE DITCH ON THE RIGHT SIDE OF THE ROADWAY AND BECAME STUCK IN THE DITCH.
