OPERATOR OF UNIT #1 STATED THAT HE LOST CONTROL OF HIS VEHICLE BUT COULD NOT REMEMBER DETAILS. OPERATOR THEN ATTEMPTED TO REPORT VEHICLE AS STOLEN.

IT APPEARS THAT UNIT #1 WAS WESTBOUND ON CTH F APPROACHING STH 58. SIGNIFICANT TIRE MARKS OBSERVED PRIOR TO, AND CONTINUING THROUGH, THE INTERSECTION. A TRAFFIC SIGN, WAS HAD BEEN ALONG THE WEST SIDE OF STH 58, WAS STRUCK. THE VEHICLE THEN CONTINUED INTO THE WOODS AND CAME TO REST AGAINST A TREE APPROXIMATELY 75-100 FEET OFF OF THE HIGHWAY DOWN A HILL. OPERATOR REPORTED NO INJURIES.
