UNIT 2, A GMC ENVOY, BEING DRIVEN BY ADDISON FILUS WITH PASSENGER CARLEY GERENCSEK, WAS WESTBOUND ON STH 136. STH 136 WAS A FOUR LANE ROAD WHICH COMES TO A ROUNDABOUT INTERSECTION OF THE ON AND OFF RAMP OF SOUTHBOUND US 12. UNIT 1 LEFT ITS DESIGNATED LEFT LANE OF TRAVEL AND WENT THROUGH THE MEDIAN, MARKED BY A CURB AND RED STAINED CONCRETE OF THE ROUND ABOUT AS UNIT 2 REMAINED WITHIN ITS LANE OF TRAVEL. UNIT 1, AS IT EMERGED FROM THE ROUND ABOUT MEDIAN, STRUCK UNIT 2 IN ITS REAR PASSENGER'S SIDE CORNER PANEL FENDER AND RUNNING BOARD, DAMAGING UNIT 2'S DRIVER'S SIDE FRONT CORNER PANEL.
