ON THE ABOVE DATE AND TIME UNIT 1 WAS NORTHBOUND ON HWY 78 SOUTH OF INSPIRATION DR. UNIT 1 WAS PULLING A HYDRAULIC PERSONAL LIFT SYSTEM. THE RIGHT TIRE BLEW AND OPERATOR LOST CONTROL OF UNIT 1 WHEN TRAILER BEGAN SWAYING. UNIT 1 CROSSED OVER SOUTHBOUND LANE INTO WEST DITCH. TRAILER DISENGAGED FROM UNIT 1 AND CAME TO A REST ON RIGHT SIDE FACING SOUTH. UNIT CAME TO A REST AGAINST A TREE IN THE WEST DITCH FACING WEST. OPERATOR WAS NOT INJURED. TRAILER AND UNIT 1 WERE REMOVED FROM THE SCENE BY EVERRETT'S TOWING. SOUTHBOUND LANE WAS CLOSED BRIEFLY FOR REMOVAL. MINOR DAMAGE TO ROADWAY FROM TRAILER WHEN TIRE WAS GONE AND TRAILER TIPPED.
