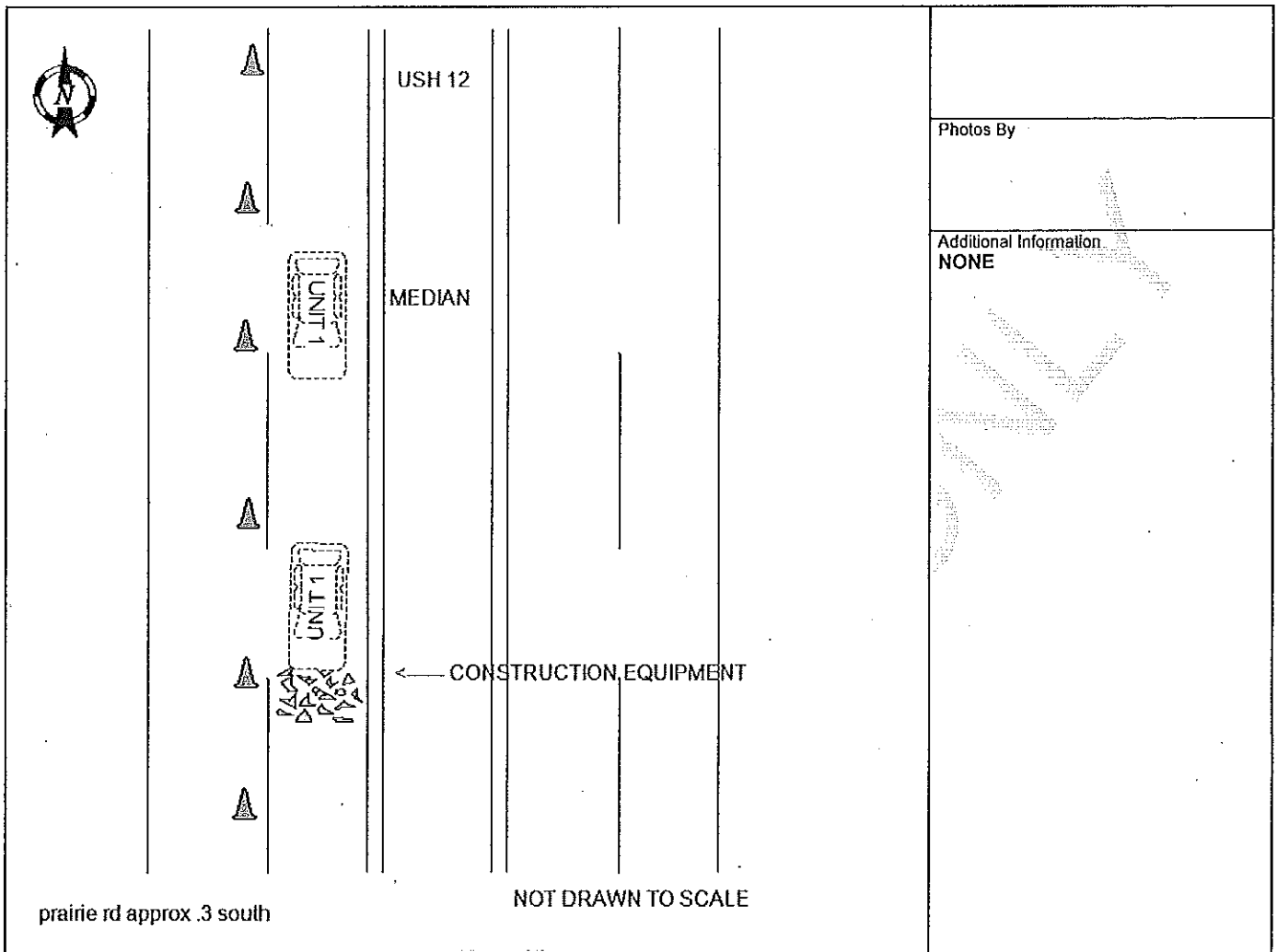

Narrative

UNIT 1 WAS S/B ON USH 12 WHEN DRIVER STATED HE HIT SOMETHING HOWEVER DIDN'T KNOW WHAT IT WAS. HE THOUGHT IT WAS POSSIBLY A TRAFFIC BARRICADE AS HE WAS TRAVELING THROUGH A CONSTRUCTION AREA. IN LOOKING AT THE DAMAGE I FELT IT COULD NOT OF BEEN A PLASTIC BARRICADE. EVENTUALLY CONSTRUCTION CREW MEMBERS FROM GASSER CONSTRUCTION SHOWED UP AND STATED A DIFFERENT VEHICLE HAD GONE THROUGH EARLIER OR JUST PRIOR TO UNIT 1 AND HIT SOME EQUIPMENT THEY HAD IN THE DITCH AND STREWN IT OUT INTO THE ROADWAY INTO THE PATH OF UNIT 1. IT IS UNKNOWN WHAT VEHICLE THAT WAS. I DID OBSERVE TRACKS GOING INTO THE MEDIAN N/B NEAR THE SCENE AND RUTS IN THE MEDIAN WHERE CREW MEMBERS STATED THEIR EQUIPMENT WAS LOCATED.
