### Narrative

ON 10/5/19 AT APPROXIMATELY 0020 UNIT 1 WAS DRIVING SOUTHBOUND ON USH 12 NEAR OLD BLUFF TRAIL WHEN OPERATOR OF UNIT ON WAS NEGOTIATING A RIGHT HAND CURVE IN A CONSTRUCTION ZONE. OPERATOR OF UNIT 1 STATED HE WAS REACHING FOR AN OBJECT ON THE FLOOR OF HIS CAR WHEN HE WENT INTO THE GRAVEL AND WAS PULLED INTO THE DITCH. UNIT 1 THEN CROSSED THE MEDIAN AND STRUCK A GUARD RAIL. UNIT 1 THEN WENT INTO THE ONCOMING TRAFFIC LANE AND CROSSED OVER INTO THE OPPOSITE DITCH COMING TO REST.
