ON THE DESCRIBED DATE, TIME, AND LOCATION, UNIT 1 WAS TRAVELING WESTBOUND. WHILE THE OPERATOR WAS ATTEMPTING TO NEGOTIATE A CURVE ON A BRIDGE, HE LOST CONTROL OF UNIT 1. UNIT 1 STRUCK THE BRIDGE RAIL AND SPUN OUT OF CONTROL UNTIL IT ENTERED THE DITCH WHERE IT CAME TO REST. THE OPERATOR HAD VISIBLE FACIAL INJURIES AND WAS TRANSPORTED TO THE LOCAL HOSPITAL.
