UNIT #1 WAS A US POST OFFICE UNIT. THE DRIVER HAD PARKED IN THE DRIVEWAY IN FRONT OF THE GARAGE, AND GOT OUT TO TAKE A PACKAGE TO THE FRONT DOOR. THE DRIVER OF UNIT #2 STARTED TO BACK OUT OF HIS GARAGE NOT KNOWING THE OTHER UNIT WAS PARKED THERE, AND STRUCK THE FRONT LEFT SIDE CORNER OF UNIT #1 WITH THE REAR RIGHT CORNER OF HIS TRUCK. THERE WAS FUNCTIONAL DAMAGE TO BOTH UNITS AND NO INJURIES. THE POSTAL UNIT DID NOT HAVE A LICENSE PLATE ON IT. I WAS ADVISED BY A POSTAL EMPLOYEE THAT THE UNIT WAS A 2016 DODGE AND IT IS SELF INSURED. WE WERE NOT ABLE TO GET ANY INFORMATION BACK BY RUNNING THE VIN NUMBER.
