7. Sauk County Animal Shelter operations update:  
Animal Shelter took in 60 dogs and adopted/reclaimed 36 dogs. They also took in 73 cats and adopted out/transferred out 21 in the month of March.

The Animal Shelter had a total of 39 calls and picked up 21 dogs and 15 cats

The Animal Shelter dealt with a total of 13 bite cases; 4 cats and 7 dogs and 2 bats.

A Pet food bank for Sauk County residents has been started to provide food for pets for those residents having financial hardship.

The Paws Walk is on Saturday May 5 from 10am to 1pm.
