1. <u>Call to Order and Certification of Open Meeting Law:</u> The meeting was called to order and compliance with the Open Meeting Law was certified by Chair Donald Stevens at 06:15 PM.

7. Sauk County Animal Shelter operations update:

Animal Shelter took in 51 dogs and adopted/reclaimed 52 dogs. They also took in 44 cats and adopted out 30 in the month of April.

The Animal Shelter had a total of 42 calls and picked up 29 dogs and 5 cats. The Animal Shelter dealt with a total of 7 bite cases; 3 dogs and 4 cats.

The Animal Shelter has changed to an "open door policy", which means they will turn away no animals. They will ask for a donation but will not require a fee.

8. Review and approve April 2011, expenses for Coroner:

9. Review and approve April 2011, expenses for Sheriff:

Motion by Sinklair, seconded by Tollaksen, to approve payment of the Sheriff's Department expenses for April 2011 in the amount of \$82, 046.34. Bills discussed. Motion carried.

There were discussions by Committee Members as well as other County Board Members on the future of staffing levels in the Jail as well as the decreasing Jail populations. Members all discussed the levels of which we offer Electronic Monitoring.

11. Discussion of possible 2011 budget overrun for Sheriff's Department.

Sheriff Meister advised the Committee that we continue to lose rental inmates. The Sheriff's Department is estimating a shortfall in revenue received from rental inmates in the amount of \$398,221.80. Sheriff Meister also advised the Committee with rising gas prices the Department may have an overrun in Field Services Fuel.
