7. Sauk County Animal Shelter operations update:

Animal Shelter took in 40 dogs and adopted/reclaimed 45 dogs. They also took in 62 cats and adopted out 20 in the month of March.

The Animal Shelter had a total of 32 calls and picked up 17 dogs and 8 cats. The Animal Shelter dealt with a total of 12 bite cases; 11 dogs and 1 cat.

The Animal Shelter is in the process of writing a grant to offer free spay/neuter to Sauk County Residents to reduce the number of unwanted cats.

The 12th Annual Paws Walk & Fun Fest is Saturday May 7th from 9:30 am to 3pm at the Sauk County Fairgrounds.
