The Committee asked why we didn't provide a 0% budget and 3% budget to the Finance Committee. They were advised that the Sheriff had cuts for both amounts and advised the Finance Committee how many positions would have been lost at each amount; however, the Sheriff could not announce what positions would be cut in an Public meeting, but could speak further on them during a closed session.

17. Department of Corrections Report.

DOC Housing Report handed out.

Captain Hafemann advises he has been meeting with Department of Corrections on a monthly basis and was advised yesterday that they continue to need beds until the end of 2010.

Captain Hafemann advises he met with Department of Corrections regarding the transfer back of inmates to the State prisons. Captain Hafemann advises all inmates from Pod A should be gone by the end of December 2010.

18. Sheriff's Report.

Electronic Monitoring for September 2010. Twenty inmates involved for 392 offender days. Electronic Monitoring collected \$4,508.50 in profit.
