7. Sauk County Animal Shelter operations update:

Animal Shelter took in 57 dogs and adopted/reclaimed 33 dogs. They also took in 63 cats and adopted out/transferred out 24 in the month of February. The Animal Shelter also took 2 parakeets and 1 rabbit and adopted/reclaimed 1 hamster, 5 rats, and 2 parakeets.

The Animal Shelter had a total of 34 calls and picked up 12 cats and 18 dogs

The Animal Shelter dealt with a total of 9 bite cases; 7 dogs and 2 cats.
