8. Sauk County Animal Shelter operations update:

Animal Shelter took in 56 dogs and adopted/reclaimed 40 dogs. They also took in 90 cats and adopted out/transferred out 42 in the month of December. The Animal Shelter also took 4 rabbits and adopted out 2 rabbits and 3 guinea pigs. The Animal Shelter dealt with a total of 7 bite cases; 6 cats. They responded to 33 calls and impounded 27 dogs and 15 cats.
