Animal Shelter took in 44 dogs and adopted/reclaimed 38 dogs. They also took in 119 cats and adopted out/transferred out 71 in the month of May. The Animal Shelter also took in 6 rabbits. The Animal Shelter dealt with a total of 16 bite cases, 11 dogs and 5 cats. They responded to 32 calls and impounded 19 dogs and 14 cats.
