7. Sauk County Animal Shelter operations update:
Animal Shelter took in 44 dogs and adopted/reclaimed 32 dogs. They also took in 162 cats and adopted out/transferred out 82 in the month of September. The Animal Shelter also took in 1 tortoise, 1 pigeon, 1 guinea pig, 1 parakeet, and 2 rabbits. They adopted out 2 chinchillas, 1 guinea pig, 2 rabbits and 1 tortoise. The Animal Shelter dealt with a total of 18 bite cases 11 cats, 6 dogs and one bat. They responded to 35 calls and impounded 18 dogs and 20 cats and 1 pigeon.
