7. Sauk County Animal Shelter operations update:

Animal Shelter took in 35 dogs and adopted/reclaimed 34 dogs. They also took in 48 cats and adopted out/transferred out 23 in the month of February. The Animal Shelter also took in 1 Guinea pig. They adopted/reclaimed/transferred 9 rabbits. The Animal Shelter dealt with a total of 5 bite cases, 3 dogs, 1 cat and 1 fox. They responded to 32 calls and impounded 12 dogs and 13 cats.


