7. Sauk County Animal Shelter operations update:
Animal Shelter took in 53 dogs and adopted/reclaimed 27 dogs. They also took in 117 cats and adopted out/transferred out 48 in the month of May. The Animal Shelter also took in 1 Cockatiel, 3 ferrets, 1 guinea pig. They adopted/reclaimed/transferred 1 guinea pig. The Animal Shelter dealt with a total of 9 bite cases 6 dogs, 1 bat and 2 cats. They responded to 42 calls and impounded 13 dogs and 15 cats.


